

The Town of Webster has a one-time opportunity to receive a special grant. It needs to hear from you in order to determine if it should take advantage of this opportunity. Webster is considering requesting funds for housing rehabilitation assistance under the CDBG-DR Program. Assistance will be provided in the form of a 0% deferred payment loan – payable only when you sell your home at some future time.

The federal government (U.S. Department of Housing and Urban Development [HUD]) is providing funding under the Community Development Block Grant Disaster Recovery (CDBG-DR) program for disaster relief (recovery). These funds will be used to address damage resulting from two (2) severe storms that occurred in 2011 (shown in #7 below).

Before the Town moves forward to request these funds, it must determine if they are needed. **Funds must be used to repair damage from the storms**, although funding can also be used for other work on a property that is not related to the storms. If the Town requests this funding, it could finance these repairs for you.
