RE: Search Warrant Execution

On July 23rd at approximately 1030 hours, after a several week long investigation, members of the Webster Police Department executed a search warrant on 79 East Main Street in the second floor. Webster Police Detectives James Hoover, Steven Cacciapouti, and Toby Wheeler were assisted by Lieutenant Michael Shaw, Officers Michael Lee, Joshua Collins, Bruce Hamm, Christopher Trainor, and K9 Officer Aaron Suss and his partner Red.

Officers recovered large amounts of several types of prescription pills for which no one at the residence had a valid prescription for, as well as over an ounce of marijuana. Along with the narcotics were packaging supplies and other instruments commonly associated with narcotics distribution such as packaging materials, scales, and over \$3000.00. Also recovered was a .22 rifle for which no one had a valid permit for. Also found were a pair of nunchaku.

An officer was injured during the entry and had to be transported to the hospital.
